### PROPOSED MERGER OF HARRODS CREEK FIRE PROTECTION DISTRICT

Residents, your Commission was very disturbed to learn in mid-April that the Board of the Harrods Creek Fire Protection District ('HCFPD") voted, without what we consider to be adequate prior public notice and input, to merge with Anchorage Middletown Fire & EMS, Eastwood Fire Protection District and Worthington Fire Protection District. Your Commission has submitted letters objecting to this merger for several reasons. First, it is the Commission's understanding that HCFPD has been debt free, and it is a violation of KRS (Kentucky Revised Statutes) 75.020 for a fire protection district which is to be merged with another fire protection district, to absorb the other's debts (Worthington has a \$4.5 million debt for their new firehouse). **Second**, our taxes will increase. The merger would allow tax rates to be raised to at least \$0.145 per \$100 of property value. Third, several years ago, HCFPD moved our equipment from the firehouse at Lime Kiln and River Road to St. Matthews. With this merger, it will be moved even farther away to the Worthington firehouse at Goose Creek Road and Hwy 22, which could lengthen the response time for Glenview residents. Fourth, our representation on the new Board will be severely diluted. **Fifth**, we feel that HCFPD, the Board of Trustees of each of the fire protection districts, and the merger steering committee established by the Board of Trustees to advise the Board of Trustees regarding the merger, have been less than transparent in maneuvering towards this merger without consideration of Glenview residents, and have potentially violated the Opens Meetings Act. Sixth, we believe that HCFPD has failed to show how this merger will enhance services for our City. We will keep you updated on our objection efforts.

### TAX AND BUDGET ORDINANCES

Ordinance No. 1 establishes a tax rate of \$0.114 per \$100 of property assessed for the fiscal year ending June 30, 2020. The Ordinance also sets the discount at 25% for tax bills paid on or before September 30, 2019.

Ordinance No. 2 establishes the Annual Budget for fiscal year ending June 30, 2020. This year's Budget appropriations total \$505,000 which is \$7,000 increase over the prior year budget. We continue to strive for efficiency in expenditures while maintaining excellence in service.

### SIGN REGULATION

Ordinance No. 3, Series 2004 is an ordinance regulating signs in the City of Glenview. Please keep in mind that no commercial advertisement is allowed on any lot, except when a lot (or house) is for sale and 1 sign not more than 5 square feet in size may be placed on the lot for sale only. A Political sign shall not be larger than 5 square feet in size and shall be located only on the lot owned. The height of any sign shall not exceed 3 ½ feet above the original ground level. In addition, signs are not permitted on public property, streets, rights-of-way, public utility poles, lamp posts, hydrants, trees or public easements. ### **TREES**

If a tree has fallen across the road first contact Harrod's Creek Fire Department (911 or 228-1351) to report the fall down. Second, call Clerk Administrator Kacy DeVore at 292-1997, and she will follow up with Harrod's Creek Fire Department and/or contact a tree removal service to clear the road. It is the City's responsibility to have public, not private roads cleared; it is not the City's responsibility to remove the debris. Please let the fire department know of any down trees as soon as possible in case there is an emergency.

The City does not have an ordinance on how people are to keep their yard. The City has had calls in the past about trees falling down and about how long people take to cut, clean up and pick up the fallen debris. The City has never taken a position on this because we don't want to boss people on how or when to take care of their yard. Please take the good neighbor approach. ### SAVE OUR TREES
