ORDINANCE NO. 4 SERIES 2010

AN ORDINANCE TO MAINTAIN A FENCE WITHIN THE RIGHT-OF-WAY OF LIME
KILN LANE, NORTH OF BRITTANY WOODS CIRCLE

WHEREAS, the City of Glenview, Kentucky has reached an agreement with the Louisville Metro Department of Public Works whereby the City of Glenview agrees to maintain a 4-board fence within the right-of-way of Lime Kiln Way, North of Brittany Woods Circle, and

WHEREAS, the 4-board fence is proposed to be located within the West right-of-way of Lime Kiln Lane approximately 23 feet from the center line of Lime Kiln Lane on property located at 5823 Brittany Woods Circle and running North parallel to Lime Kiln Lane from the center line of Brittany Woods Circle approximately 10-25 feet.

WHEREAS, Louisville Metro Department of Public Works has agreed to waive a License Agreement bond, insurance and permit fee which would normally be required for a 4-board fence within the public right-of-way.

NOW, THEREFORE, BE IT ORDAINED THAT THE CITY OF GLENVIEW, KENTUCKY AGREES AS FOLLOWS:

1. The City of Glenview shall maintain the 4-board fence;
2. The 4-board fence to be maintained by the City of Glenview is proposed to be located within the West right-of-way of Lime Kiln Lane approximately 23 feet from the center line of Lime Kiln Lane on property located at 5823 Brittany Woods Circle and the fence will be parallel to Lime Kiln Lane and will extend North from the center line of Brittany Woods Circle approximately 10-25 feet.
3. The City of Glenview shall remove the 4-board fence and restore the Louisville Metro right-of-way at the request of Louisville Metro Government;
4. The City of Glenview accepts the responsibility of maintaining, protecting and preserving the 4-board fence and any liability which may be associated with locating the fence within the public right-of-way.
